Notice of Revision (Increase) of Dividend Forecast

At the Board of Directors meeting held on May 9th, 2018, Brother Industries, Ltd. (the “Company”) resolved to revise (increase) the company’s dividend forecast for the fiscal year ending March 31, 2018 as outlined below.

The resolution will be confirmed at the Board of Directors meeting, which is scheduled to be held in May 2018 after legal audit concerning financial statements of the year.

1. The reason for revision

Brother Industries, Ltd. sets a basic policy of consolidated dividend payout ratio to about 30% and according to its financial results, taking into consideration maintaining adequate levels of internal reserves for investment for further growth and cash flow.

Under this policy, the Company examined its circumstances, including the financial results of this fiscal year, and plan to increase the year-end dividend per share by 6 yen to 30 yen per share from our original forecast of 24 yen. As a result of this increase, the annual dividend for this fiscal year will become 54 yen per share with the 24 yen dividend for the end of the second quarter, which had already been paid.
