

Choosing a location



A WARNING





Choose a location where the temperature remains between 50°F and 95°F (10°C and 35°C) and the humidity is between 20% to 80% (without condensation).





DO NOT allow this product to come into contact with water. This product should not be used around standing water, including a bath tub, sink, or swimming pool; around appliances containing water, including a refrigerator; or in a wet basement.





DO NOT expose the product to direct sunlight, excessive heat, open flames, corrosive gasses, moisture or dust. Doing so may create a risk of an electrical shock, electrical short or fire. It may also damage the product and/or render it inoperable.


ELECTRICAL HAZARDS

There are high-voltage electrodes inside the product. Before you access the inside of the product, including for routine maintenance such as cleaning, make sure you have unplugged the power cord from the AC power outlet, as well as any telephone/RJ-11 or Ethernet/RJ-45 cables from the product.
